- Start documenting all work and insurance communications today
- Contact your hospital's patient navigator about financial assistance
- Visit Triage Cancer, Patient Advocate Foundation, and CancerCare websites
- Don't accept insurance denials without appealing
- Talk openly with your care team about financial concerns

For Healthcare Professionals:

- Proactively discuss financial toxicity with patients
- Connect patients with financial counselors early in treatment
- Provide information about assistance programs and resources
